LETTER OF INVITATION for Scientific Conference

TECHNOLOGY AND LAW



Technological development brings about major changes in social relations. The rapid development of technology is more and more often the reason for changes in legislation. In this race, law is trying to catch up with technological developments. It is predicted that law will undergo greater changes in the next 20 years than it has in the last two centuries.

There is a need to explore how technology can benefit the law and how its use should be regulated to ensure the rights of subjects. In addition to changes in people's everyday activities, new technologies are having an increasing impact on the legal

professions. For example, it would be interesting to answer the question of how the application of technology affects individual legal professions. Are there any legal activities in which technology *only* assists humans *or replaces* them entirely, *or is it totally* inapplicable? These questions call for an examination of the interaction between human and technological factors and/or the outcome of that interaction. Evidence on the use of artificial intelligence in drafting legal documents and resolving legal disputes raises the question of the limits of this use.

It must be acknowledged, however, that this is only a small part of the questions that need to be answered in this century. We invite you to participate in the planned conference, which welcomes papers from all areas of law as well as from other fields of knowledge relevant to law. The paper should not have been offered in another edition or published.

The Scientific Conference on *Technology and Law* is dedicated to the anniversaries of leading legal scholars who teach or have taught for many years at the Law Faculty of University of Plovdiv – Prof. Vasil Mrachkov, DSc.; Prof. Polyana Goleva, PhD; Prof. Yonko Kunchev, DSc.; and Assoc. Prof. Krassen Stoychev, DSc. Most of them are among the founders of the Law Faculty.

The conference will take place on 30 and 31 October 2024 at the University of Plovdiv. To participate in the conference, you can submit the attached registration form to forums_law@uni-plovdiv.bg with the topic *conf24* no later than October 7, 2024. Papers will be published in a peer-reviewed edition. The program will be announced up to seven days before the conference date.
